A RESOLUTION NOTIFYING THE BERNALILLO COUNTY CLERK OF THE AT LARGE POSITIONS TO BE FILLED FOR THE VILLAGE OF LOS RANCHOS DE ALBUQUERQUE FOR THE 2023 REGULAR LOCAL ELECTION TO BE HELD ON TUESDAY, NOVEMBER 7, 2023.

**BE IT RESOLVED** by the Governing Body of the Village of Los Ranchos de Albuquerque that this serves as notification to the Bernalillo County Clerk of positions to be filled at the next Regular Local Election, 1-22-4 (A) NMSA 1978:

**A. DATE AND PURPOSE OF ELECTION.** A Regular Local Election shall be held on ***Tuesday, November 7, 2023***, between 7:00 a.m. and 7:00 p.m. for the purpose of electing the following **At Large Positions**:

- **One Position for a Mayor for a four-year term**
- **One Position for a Trustee for a four-year term**
- **One Position for a Trustee for a four-year term**

**B. POLLING LOCATIONS:**  
Polling locations will be established throughout Bernalillo County.

**C. DECLARATIONS OF CANDIDACY:**

- I. A candidate for a position that will be filled at a regular local election shall file a declaration of candidacy with the proper filing officer with the Bernalillo County Clerk located at 415 Silver SW, Albuquerque, NM 87102 between the hours of 9:00 a.m. and 5:00 p.m., on Tuesday, August 29, 2023.
- II. A candidate shall file for only one position in the same local government but may file for a position in more than one local government on the same filing day.
- III. A declaration of candidacy shall not be amended after it has been filed with the proper filing officer.
- IV. Each declaration of candidacy shall be delivered for filing in person by the eligible candidate or by a person acting by virtue of written authorization. The proper filing officer shall not accept for filing from any one individual more than one declaration of candidacy.
- V. Write-In Candidate Filing Day; the declaration shall be filed for the regular local election with the Bernalillo County Clerk located at 415 Silver SW, Albuquerque, NM 87102 between the hours of 9:00 A.M. and 5:00 P.M., on Tuesday, September 5, 2023.
- VI. Candidates Last Day to Withdraw shall be filed with the Bernalillo County Clerk located at 415 Silver SW, Albuquerque, NM 87102. between the hours of 9:00 A.M. and 5:00 P.M., on Tuesday, September 5, 2023. (1.) the candidate files with the proper filing officer a signed and notarized statement of withdrawal as a candidate in the regular local election.

VII. The Secretary of State's Office will notify candidates of qualification for appearance on the ballot for the position specified in the declaration of candidacy and notify each candidate in writing no later than 5:00 P.M. on Friday, September 8, 2023.


**D. CANDIDATE TAKES OFFICE:**

The term of office of a candidate elected in a regular local election or ensuing top-two runoff election shall begin on January 1, 2024, following the candidate's election, and the candidate to whom a certificate of election has been issued shall take the oath of office before entering upon the duties of office.
