 RESOLUTION NO. 2022-08-04**

**A RESOLUTION ALLOWING THE VILLAGE TO SUBMIT A BALLOT QUESTION
 TO THE VOTERS OF A LOCAL GOVERNMENT IN
 THE 2022 GENERAL ELECTION**

WHEREAS, the Village Board of Trustees (the "Board") of the Village of Los Ranchos de Albuquerque, New Mexico (the "Village"), has determined upon its own initiative to submit to an election the question of the issuance of its general obligation bonds up to \$8,000,000 and for the purposes hereinafter specified at the General Election on Tuesday, November 8, 2022, in accordance with Section 1-16-2, NMSA 1978, Section 1-16-3(B), NMSA 1978, and Sections 3-30-1 et seq., NMSA 1978, as amended; and

WHEREAS, it is the opinion of the Board that it is necessary and in the best interests of the residents of the Village that there be submitted to a vote of the registered qualified electors of the Village, the questions of whether the Village should issue its general obligation bonds for the purposes hereinafter specified; and

WHEREAS, it is the opinion of the Board that it is necessary and in the best interests of the residents of the Village to provide for the acquisition of property for use as open space within the Village.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE BOARD OF THE VILLAGE OF LOS RANCHOS DE ALBUQUERQUE, NEW MEXICO AS FOLLOWS:

Section 1. The Board does hereby propose that the following question be included on the ballot and submitted to the registered qualified electors of the Village of Los Ranchos de Albuquerque, New Mexico, at the General Election on Tuesday, November 8, 2022:

General Obligation Bond Questions:	<p>“Shall the Village of Los Ranchos de Albuquerque, New Mexico be authorized to issue up to \$8,000,000 of general obligation bonds for the purpose to acquire, enhance or otherwise improve property for use as open space?”</p> <div style="border: 1px solid black; padding: 5px; margin: 10px auto; width: 80%;"> <p>FOR the general obligation bonds <input type="checkbox"/></p> <p>AGAINST the general obligation bonds <input type="checkbox"/></p> </div>

Section 2. The Village Mayor and Village Clerk (each an "Authorized Officer") are hereby authorized and directed to deliver a copy of this Resolution to the Bernalillo County Clerk not less than seventy days (70) before the election. Pursuant to Section 1-16-3(B) NMSA 1978, the Bernalillo County Clerk is hereby requested to certify the foregoing ballot question to the Secretary of State not less than sixty-seven (67) days prior to November 8, 2022, (i.e. no later than September 2, 2022).

Section 3. The County Clerk of Bernalillo County is requested to conduct the Election in accordance with this resolution and the Election Code, Sections 1-1-1 through 1-26-6, NMSA 1978, as amended, pursuant to Section 1-16-1, NMSA 1978.

Section 4. The Authorized Officers are hereby authorized and directed to take all action necessary or appropriate to effectuate the provisions of this Resolution.

Section 5. If any section, paragraph, clause or provision of this resolution shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any of the remaining provisions of this resolution.


Section 6. All resolutions and ordinances, or parts thereof, inconsistent herewith are hereby repealed to the extent only of such inconsistency. This repealer shall not be construed to revive any resolution or ordinance, or parts thereof, heretofore repealed.

Section 7. All action heretofore taken by the Board and officers of the Village not inconsistent with the provisions of this Resolution and directed toward the calling and conducting of the Election be, and the same hereby is ratified, approved and confirmed.
